We are a non-profit club (501-C7) which raises money for and participates with various local children's charities. Dues and donations are not tax deductible. We strive to promote exciting, safe & fun ways to enjoy our Corvettes. We hold business meetings on the second Saturday of each month. Our monthly business meeting usually incorporates a social time afterwards. Our socials are always fun and are focused around food & drink. We've had swimming parties, barbques, cookouts, day trips and weekend trips. We participate in mountain tours, holiday parades and several homecoming parades at local area high schools. We also participate with several sister Corvette clubs in car shows, drag racing, and autocrossing. After an initiation fee of \$7.00, club dues are only \$8.00 a month, per family, and are to be paid quarterly. These dues go to cover the costs of running the club, mailing newsletters, and subsidizing the costs of our meetings. Club officers serve as volunteers. NCCC dues are \$30.00 a year.

News from the NCRS

The National Corvette Restorers Society is a great source for learning about your pre-84 Corvette. Judging manuals are available that describe in detail how various areas of your car was assembled when it was shipped from the factory. It is a lot of fun to go through a judging manual that is applicable for your model year and see what is correct and what is not. Restoring a car to appear as it did when it was delivered from the factory may not be for everybody. However, if your going to replace a part, knowing what the correct part number is or how it was originally configured may make a difference in the future life of the car. The judging manual covers four areas of concern: mechanical, chassis, interior, and exterior. During the judging process, if enough points are accumulated in each category, a Top, Second or Third Flight designation may be appropriate. A Flight judged car has a lot of significance as to the originality and condition of the car for whatever reason.

NCRS has a WEB site (www.NCRS.org) that is very informative. It contains a discussion board area that fields questions and answers from many NCRS members. The questions are about everything and anything related to Corvettes. I dare say that someone will answer any question you may have with knowledgeable background and/or experience given a reasonable amount of response time. You need to check it out!

There are a few local events coming up in the near future that are sponsored by the Carolina Chapter. On May 6th, a Spring Fling meet will be held at Knight's Cars Inc. (704 289 4446) on highway 74 in Monroe. It will be a small meet with a few cars. Judging will be from 9am until 2pm and it will be a great opportunity to learn about the process. If you are in the area, stop by. The Carolina Chapter is also hosting the "Fall in the Mountains" road tour/meet in Banner Elk on September 29-October 1. *This is a lot of fun* and it is a great way to have your car judged without a lot of hassles. This is well worth the trip if you can. More on this as the date gets closer.

The main purpose of NCRS is to *learn about Corvettes*, *promote Corvettes* and *to have fun*. What could be better?

The April QCCC business meeting was held at Lowe's Motor Speedway. All officers were in attendance. Thanks were given to Tony Prior, E.O. Oakley and Jon Elliott for their contributions to last month's newsletter. Any new newsletter contributions are due April 25. There is a drive to get a commemorative Corvette stamp in 2003. Please sign petition if in favor. There is event in North Davidson St. area on Father's Day weekend and a car show in Kings Mountain at Classic Diner on April 16 from 11 a.m. to 3 p.m. Jeff needs to include new members' section in newsletter and needs pictures and bios from new members. Jody Austin has purchased a 1996 Grand Sport.

Regarding pictures and video taken of parade lap on April 1, Fred will e-mail club members a reminder to place orders with Candy Lake at the next business meeting. Fred will also insert reminder in newsletter regarding laminated signs for sale. Deadline for selling community service books is April 24. Autocross flyers are in distribution. Fred has received several offers to work autocross. Board needs list of volunteers from Jon Elliott who are working Johnsonville grill during race weekend. Regarding Savannah trip, personalized packets are ready to be distributed. Greg Beavers will be the bartender for Friday night's pizza party. Caravans are leaving at 7:00 a.m. and 2:00 p.m. The main caravan is leaving at 9:00 a.m., with a driver's meeting at 8:45 a.m. Nancy is planning two more progressive dinners. Charlie Brackett will not be hosting September meeting, as his road is not in good shape. September meeting has been rescheduled for PJ's. Regarding mountain trip, 23 out of 30 rooms have been taken at the Balsam Mountain Inn. The other rooms held for QCCC are being released to the public.

Subject of insurance and club membership affiliation with NCCC is tabled.

Tony Prior has asked Fred for two versions of newsletter, one in PowerPoint and one in Word. Tony will post next newsletter on club's website with password protection in Adobe Acrobat format. Tony will test this electronic format by e-mailing the newsletter to a few club members. In 60 days, Board will send first version of newsletter to about half-dozen members. If successful, newsletter will be posted on website. Goal is to put monthly newsletter on the website to be downloaded or just to view. However, website cannot store newsletter archives. This will be done by Candy, who will print out and store newsletter copies in club archives.

Scott Hamilton has had one meeting of the Dealership Committee. Dealerships have not and are not actively seeking out club. Need club demographics as to average income, age, number of Corvettes, etc. Need someone to do face-to-face negotiations with dealerships. Also need list of what club wants from dealerships, such as possible free QCCC membership with Corvette purchase, but bylaws would need to be changed for this. Good possible sponsor includes Bill Lambert with Collins & Aikman, producers of convertible tops.

Regarding change in bylaws, letter has to be sent to secretary of club from the person suggesting change and published in newsletter. Letter to request change of reimbursement language regarding expenses to VP Social and/or VP Competition from "up to" \$500 to "not to exceed" \$500. Executive board can only spend up to \$1,000 per year on capital expenditures. Board can authorize VP Social to spend as much as needed as long as it is not on capital expenditures. Question raised of what is an NCCC charter. Copies of articles ordered from N.C. Secretary of State. Bylaws specify mandatory NCCC membership. Club currently has \$1 million liability policy protecting non-club members from suing club members and/or club. Eddie is currently checking with various insurance companies to obtain rate estimates for club. Possibility of changing bylaws to state NCCC membership is voluntary, not mandatory. Fred and Eddie to discuss drafting proposal with several alternatives to include in future newsletter and get feedback from members.

Regarding NCCC numbers in membership list, any member who hasn't been assigned an NCCC membership number will be noted in membership list as "NCCC application in process."

Flyer regarding cruise night at South 21 will be included in next newsletter, along with event flyers.

Meeting adjourned at 9:05 p.m.

Dear Candy,

In compliance with QCCC By Laws Article X, Section 1, paragraph a. consider this as a request for By Laws amendment. This request has been discussed and approved by the QCCC Board. It is believed by the Officers that the language regarding the independent commitment of Club funds by the VP of Social Events and VP of Competition should be changed.

Current By Laws wording:

Article IV Section IV, paragraph C: "The Vice President of Competition shall have the authority to spend up to and including thirty percent (30%) (or up to \$500.00)..."

Article IV, Section IV, paragraph D: "The Vice President of Social Events shall have the authority to spend up to and including thirty percent (30%) (or up to \$500.00)..."

Proposed By Laws wording:

Article IV Section IV, paragraph C: "The Vice President of Competition shall have the authority to spend up to and including thirty percent (30%) (not to exceed \$500.00)..."

Article IV, Section IV, paragraph D: "The Vice President of Social Events shall have the authority to spend up to and including thirty percent (30%) (not to exceed \$500.00)..."






Best of Show



On March 13-15, 2000, I opened my '99 Christmas present: the 3-day **Bragg-Smith Advanced Driving School for Corvettes** located in Pahrump, Nevada. It was a good Christmas.

Ann and I left Charlotte for Las Vegas on Thursday, March 9th compliments of USAirways Frequent Flyer program. After spending a couple of days enjoying Vegas without even putting a quarter in the "one-armed bandits", but really enjoying the sights and people watching, we headed for the booming metropolis of Pahrump. Pahrump is located about 60 miles from Las Vegas, and about half the distance to Death Valley. Pahrump claims a population of about 30,000, but you can't prove it by us. We had a choice of one of the two motels (a Days Inn or the Saddle West) and one main street surrounded on all sides by desert and more desert. Pahrump does have the one winery in the state of Nevada with a nice restaurant attached – more on this oasis later. Sunday brought a day trip to Death Valley, then an early bedtime to get ready for Bragg-Smith at 08:15 Monday morning.

The Bragg-Smith Level One program is a 3-day school using only MY2000 C5 Corvettes. The Vettes are all coupes and FRC 6-speeds on loan from Chevrolet and are "bone-stock", down to the Goodyear EMTs. The only modification is a two-way radio for the instructors to coach and critique each driver. Course time is split about 25% classroom and 75% track. During the 3 days we put in approximately 400 miles on the track and shifted between 4000 and 5000 times. (My arms and legs thought it was more!)

Day 1: Conventional vs. ABS braking, skid control, visual scanning, seating position, heel & toe downshifting, and learning the traction limits of the C5 on dry asphalt (see panoramic view mentioned below).

Day 2: Endless back and forth on a 1000 ft. straight practicing heel and toe; the regimen: accelerate through the gears into 4th to 60 mph, then brake and downshift 4th to 3rd, 3rd to 2nd, and 2nd to 1st. Then hang a U-turn and do it all over again. Whoever thought doing this in a C5 would get to be tiresome, and boring. Finally TRACK TIME on the 10 turn - 2.2 mile course. Time to put all we had learned to practice. YEAH RIGHT. My legs hurt, I missed shifts, sweat running into my eyes, got slower and slower, all in all sorta like patting my head while trying to rub my tummy. This was the night when Ann and I really appreciated the Pahrump winery. I wasn't sure I wanted to have any more fun.

Day 3: The morning came with some dread, 8 more hours, if it wasn't already paid for, I'm outa-here. Started the day with more heel and toe practice – hey this was starting to work; on to the track – hitting the shift and turn-in points, speed was increasing, legs weren't hurting. It was all coming together – not perfect by a long shot, but certainly getting better and better. This was actually fun, 4:30 and "graduation" came too quick, I wasn't ready to finish, and I wanted more track time!

Things I learned:

- An apex is not a flightless bird, and something I was always about 6" to 1 foot from hitting just right.
- Heel & Toe downshifting has nothing to does with using the heel or the toe.
- A 360° panoramic of the Nevada desert through the windshield of a C5 at 45 mph is quite interesting.
- Active Handling don't leave home without it.

When Ann came to pick me up the last day, Rupert Bragg-Smith took her for a "hot" lap to show her what I had spent 3 days trying to learn. He makes it all look so easy.

All in all, it was a great Christmas present. By the end, I was really enjoying myself, learning a lot, learning how much I needed to learn, and as Rupert told us on Day 1, we would change the way we drove forever. What's next? I would like to repeat Level One A or B. Class sizes are limited to 12. Wouldn't it be great to have 12 QCCC members caravaning to Nevada and all taking the class at the same time? **Volunteers let me know!**

Floyd Garret Muscle Car Museum

A few weeks ago I was in Gatlinburg for the weekend and found I had some idle time on Saturday morning. I am an avid viewer of classic car and hot rod shows on TV and I noticed many of them mention Floyd Garret's Muscle Car Museum in Sevierville, TN. So, with this time available, I drove to Sevierville, which is only 13 miles from Gatlinburg. Good Golly, what a treat! If you are into 60's and early 70's muscle cars you have to go to this museum.

After arriving at 9:30 and purchasing a ticket I discovered I was the only one in there so I had the run of the place. The museum has about 100 cars and they are beautifully restored. The museum owns many of them and the rest are there on loan. The displays are divided by marque, Chevys in one area, Mopar in another and Fords in another. There was a ZL1 (All Aluminum version of the L88) motor on an engine stand along with all of the other models of the 427 c.i. engine, which are many. If you remember, there were only 2, 1969 Corvettes documented as having the ZL1 (580HP) engine, although more can be found at car shows now, and all of them supposedly original. --- Hmmm! I wonder how that can be? Can you say "Counterfeit"? He has a '71 or '72 Vette, I can't remember which, on display that he bought new in '71, sold it a little while later, then a couple of years ago found it again, restored it, and now has it, along with the original paperwork, on display in the museum. What are the chances of that happening? There is a '69 Camaro that is factory stock with the ZL1 motor and due to the scrutiny the cars are under I doubt it is a counterfeit. Only 69 of these were built. A few notable NASCAR cars are on display also. One of them was a '66 Chevelle that Smokey Yunick built for the '68 Daytona 500, but was outlawed by NASCAR because of the innovations he had incorporated into it. Many of these innovations are now commonplace in today's cars. I guess that shows how far outfront of the curve Smokey was. Another NASCAR car of distinction is one that is an exact copy of the '63 Chevy Junior Johnson drove, all the way down to the Chevy 427 "Mystery Motor". I stayed about an hour and a half and no one else came in during this time, but as I was leaving people started arriving.

They have 'Vettes, Chevelles, Hemi 'Cudas and Challengers, sleeper 409 Chevys, 442's, GTO's, all flawlessly restored, and the list goes on and on. For those of you that are in my age group, let's just say you can remember carrying a draft card and worrying about 'Nam, this is a fantastic trip down memory lane. The tour brings back many thoughts of those Saturday night, stoplight duels many of us engaged in. I have gone to both of the Autofairs, spring and fall, at the Speedway for many years and have never seen a gathering of such nice and unique automobiles as there was at this museum.

Still cameras are allowed, but video tape or movie cameras are not. I forgot my camera when I went and I'm still kicking myself for that error. Admission is \$8. They have a gift shop with memorabilia items. The museum is on Highway #66 in Sevierville, right next to the Chevrolet dealer. Get to Sevierville by exiting I-40 at exit #432 in Tennessee, onto Highway #411, then it is about 20 miles to the intersection with Highway #66 and the museum is approx. a mile from the intersection. If your significant other doesn't want to go to the museum all of the outlet stores in the world are in Pigeon Forge, just a couple of miles away.
