

Dear Fellow Members,



Minutes From QCCC Directors' Meeting, Friday, June 22, 2001

The June directors' meeting was held at the home of Paul and Priscilla Pelkey. All officers were in attendance as well as Paul Pelkey. President Fred Fischer called the meeting to order at 7:35 p.m.

Bylaws:

It has been suggested that the bylaws need to be thoroughly reviewed and updated to more accurately apply to a large and progressive club. The last major review was in May 1999 of the June 1994 bylaws. Rick Witcher led that committee and has volunteered to do so again. The Board agreed that a committee comprised of club member volunteers should be formed to review the current bylaws and recommend changes. The Board would establish a deadline and state its view on each recommended change. Current Bylaws can be changed as per the following rules as set forth under Article X, Section I, paragraph a.

"These Bylaws may be added to, altered, or rescinded by a two-thirds vote of the members present at any regular meeting of the club, provided such additional Bylaws amendment or repeal has been proposed in writing to the Secretary, who shall have included in it a notice of the meeting to the members at least seven days before the date of the scheduled meeting."

Fred will e-mail the membership to solicit volunteers for a Bylaws Review Committee.

QCCC Huggers:

The blue huggers given to member families at the June Meeting were well received. The Board approved purchasing another 100 in a different color.

Charity Poker Run July 28:

Jody Austin has ordered 100 poker hands for this event. The Board approved the \$79 expenditure. 


Hungry Mother State Park, Marion, Va. Sunday, August 19, 2001

TECH TIP

Car Washing Tip

We all love our Corvettes to be clean and shiny, so here's a tip that has several benefits. One of the keys to a good wash, is how we dry our cars. I've found the best method to do this without removing any wax, is to use a large cotton towel, throw it over the body panels and slowly drag the towel over the areas you wish to dry. You'll find this method speeds up the process, and more importantly, since only the weight of the towel is being dragged over the surface of the paint, virtually no wax will be removed, and equally important, no swirl marks will be created in your paint job. Try it, and let me know what y'all think.

P.S. I find 2 large towels will thoroughly dry our 'Vettes in this manner.

CORVETTE FORUM CRUISE-IN MAY 24 – MAY 27, 2001

One of the goals Kay and I set for this year was to visit the National Corvette Museum and to tour the GM Corvette Assembly plant where our new baby was built. Our prime opportunity arose when we heard about the Corvette Forum Cruise-In over the Memorial Day weekend. This was going to be our first trip to Bowling Green and we wanted to make it memorable.

Thursday, May 24

We left Charlotte at about 8 a.m. (wanted to leave at 7, but Kay's hair wouldn't cooperate) and began our journey through the Smoky Mountains. The scenery was just beautiful until the clouds rolled in and the rains came. We also hit the usual construction and traffic. We had to arrive in Bowling Green by 5 p.m. to check in and get our info packs, and we were beginning to get a little concerned about the time until we passed a sign that said "enter central zone". We had just crossed over into the Central Time zone and gained back the hour we lost in the beginning.

We arrived at the museum at about 4:30, checked in, received our packets and were told to be back there at 5:30 for a caravan to the bar-b-q dinner. We quickly went to our hotel to check in and returned to the museum to line up with the other 400 or so Corvettes. Everyone got out of their cars and began to mingle. We met many new friends from all over the country. I counted about 30 different states represented there. We caravaned to the 1869 Homestead for an excellent dinner and good friendship. We parked our Corvettes on the front and back lawn and again, we all mingled and admired each other's Corvettes. Kay and I then saw a Corvette we knew we recognized. It wasn't one you soon forget. It was the muti-colored C5 belonging to one of QCCC's newest members, Donna Littlejohn. Her car was receiving quite a bit of attention and we went over to say hello. She was happy to see a familiar face and we all went in to have a wonderful dinner. It's quite amazing how quickly people who drive Corvettes become friends and family, no matter where they are from. After dinner, some went to ride go-carts, but we turned in for the evening after a long drive. Tomorrow was to be a big day for us!

Friday, May 25

We were up early, had breakfast, and at the museum by 7:30. There were other events scheduled for the day, an autocross, a burnout contest, drag races, and a car show, but we wanted to make sure we got our tickets for the factory tour. We parked the car in front on the museum and took pictures, and began to read the engraved bricks on the sidewalk. We found the QCCC brick and took a picture of it. People began to show up and a line formed at the door of the museum. The museum officials were so taken with our enthusiasm that they opened early for us to enter. We got our tour tickets for the 10 o'clock tour and spent the next hour and a half touring the museum. This being our first trip to the museum, we weren't sure what to expect. There are some beautiful Corvettes there, many that are one of a kind, and I think they have done an excellent job considering the museum is only 6 years old. They told us it would only get better. It is well worth the trip for any Corvette enthusiast.

The highlight of our trip was now upon us. We cruised up to the factory and took our seat in the waiting area. While we were waiting. I talked to a recently retired veteran of UAW. He told me he had been building Corvettes for 30 years and had some wonderful stories to tell. He had a hand in all the Corvettes I had owned, and he said the improvements in manufacturing these beautiful cars were incredible. Now, for the tour: After a brief film presentation on safety, we began. There is over 7 miles of conveyor system in the plant and parts are moving all around you. The body and the frame and drivetrain are assembled separately and married at the end of the line. This is different from any other auto assembly. It's quite a unique system. When we got to the end of the line, where they do their inspections, the gentleman on the line approached Kay and asked her if she would like to start a car for the first time. With her face beaming, she climbed into a brand new red Z06 and turned the key. The car roared to life for the very first time, and she did all of the inspections on the car. She received a nice certificate for her part in the birth of this new Z06. What a treat for her! After the tour we went back to the museum to see what we had missed and then had lunch. After lunch we returned to the museum for the car show. There were some very impressive Corvettes there, but I didn't see any that were more impressive than ours. We also talked to some of the vendors there as to what new products they had and the many different ways to "beef up" the engines. Friday night was a free night so we had dinner at a local restaurant and hit the mall to do some quick shopping. We had a full day.

Saturday, May 26

Saturday was more of a low-key day. There was a road tour and many seminars on different aspects of the Corvette. We took in a couple of the seminars and learned about the Corvette power train and how the C5 came about and the testing involved. We were also introduced to the new Electron Blue color for 2002. As most of you know, the Dark blue and Bowling Green green have been discontinued, as well as the white for the Z06. These colors had only accounted for about 4% of sales, so they decided not to continue them for 2002. They also discontinued the mag wheel option for 2002. The one other thing we did learn was that the 50th anniversary edition was going to be a C5 and it will be spectacular. After the seminars, we took a tour of downtown Bowling Green, which didn't take long, and then went back to the hotel to relax and get ready for the banquet that evening.

We arrived back at the museum at 5:30 for the happy hour and the banquet. We met more new friends and sat down for a meal and good fellowship. There were many awards given out and QCCC made a definite impact. Donna Littlejohn won 2 awards, one for women's autocross and a celebrity's choice award for her car. A great night had by all.


Sunday, May 27

So ended day one!


The rest of the trip was less eventful, but a ton of fun for all. Dinner was superb, the drive home incomparable!




