



NEWS FROM THE AUTOMOTIVE FRONT THE SMART CAR

Your editors are roving the world in search of new and exciting automobiles for

our Corvette enthusiasts. Iris discovered this in Italy. Yes, it looks like half a car. The Mercedes Benz Smart is powered by a lightweight and recyclable turbo-charged aluminum engine weighing only 59 kg (that's about 130 pounds), gets 60 mpg and goes from 0 to 60km/h is 7 secs. (Note 60 km is basically 36 mph!). Plus it has thermogranulate



plastic body panels that can be changed in 90 minutes if repairs are needed! Sure looks like 4 wheels and 2 doors... I wonder where they put the engine?

MORE ON DIGITAL PHOTOGRAPHY - PRINTING PHOTOS

Now that you've taken those digital pictures and emailed them to friends, what happens when you want to have color prints??

You don't need a special printer or indeed any at all to get "hard copy" images. Many one-hour photo shops offer prints from digital files; just bring them a CD or your memory card and indicate which image file you want printed. Wal Mart and others have good do-it-yourself systems that have the ability to read the different types of memory cards or CDs, and allows you to edit or crop images. You select print sizes and indicate how many of each image. It is all ready within an hour at a cost of about 30 cents per print!

If you are considering purchasing a printer for your photos, be sure to get a "photo" printer. These are ink jet printers that are distinguished by having six or more ink colors (regular inkjets have only four colors). The extra colors are necessary for finer tone renditions.

Most printers take standard size paper and can be used as the one and only printer you need. Caution however, some come can print only 4x6 size photos. Some printers even offer "slots" to insert your memory card so you can by-pass a computer. Of course there are "jumbo sized" printers available for a higher price.

The cost of printing digital photos can be pricey. Besides the cost of the ink, you will be using special papers to match the feeling on the photos. Glossy for some and matte surface for others. Do not expect to get quality results on regular paper! Furthermore, the best quality prints are made on paper matched to the printer and sold by the printer manufacturer.

Also for the very serious minded: most ink jet printers come with "dye based" inks. These are relatively inexpensive and produce excellent photos, but have a limited life span. More expensive and permanent are the "pigment based" inks and the printers that require them.

Carolina Motorsports Park October 25 & 26 by: E. O. Oakley

What is an article about Beammers doing in the QCCC newsletter?

Well somebody had to take some "American Iron" amongst all them Europeans (and a few rice burners) to uphold the honor! So ramrod John Liebe rounded up 4 more folks from QCCC and away we went to Kershaw, SC.

In reality, as the only 5 Corvettes there were welcomed and encouraged by all.

The two day event was extremely well organized and consisted of a lot of track time – in 30 minutes sessions. There were several classroom sessions each day including a walk around the entire 2⁺ mile track with an instructor giving tips and advice along the way.

In the less advanced groups, an instructor rides with you and gives pointers and feedback on your driving in an encouraging professional manner designed to improve your skills. The real beauty of our Corvettes is the ability to ride to the tracks listening to Jimmy Buffet or Alan Jackson on your CD player in total comfort, and then have a car that can change from street dress to track attire and outperform almost any car on the track. For most of us, this was the first time we had the person in the passenger seat, tell us to go faster in the turns and stay off the brakes! In my case the driver – not the car – is far and away the limiting factor.

I went to this event – a first for me driving my own car – with a bit of apprehension. I had 3 goals – 1) DON'T DAMAGE THE CAR, 2) Improve my skills, and 3) Have some fun. All three goals were met. So, if you have a desire to really improve your driving skills, learn how these Corvettes of ours can really perform, and were engineered to be driven, I highly recommend participating in one of these events. John Liebe, Jody Austin, Phil Smith, Gary Artis, and I all plan on doing more, so see anyone of us for details. In fact some will be going to an event at VIR (Virginia International Raceway) in late February, so sign up. One word of caution – this can be highly addictive – just ask Jody.

Some leaks and rumors about the C6

Some details are emerging about the all-new, 2005 Sixth Generation Corvette. The new chassis will be shared

with the Cadillac XLR. The C6 will be five inches shorter than the C5 in overall length but


retains the same interior room! Also coming is improved quality and upscale interior materials. The standard 6.0-liter V-8 is expected to deliver 400HP and around 400 lb-ft of torque, just under the 405HP figure of the current ultraperformance Z06 C5!

The Z06 may not be in production until 2006, but the Z51 option for the C6s will



include bigger brakes with cross-drilled rotors, specifically tweaked tires, gear ratios, springs, shocks and sway bars, plus a engine oil cooler and a power-steering cooler for serious off-road performance work.

Among other things the HUD on the new car may have a built-in G-meter, a power top may



finally be available (long overdue) on the convertible, and a six CD indash changer will be an option, as will an onboard navigation system.

Coupes will go

into production in Spring 2004 with convertibles starting production in late Summer. Sorry, Torch Red is no longer in the offering (probably to be replaced with Precision Red).
