



## **Awards & Recognition Policy** **Update Approved April 1, 2018**

The following is a description of Queen City Corvette Club's Awards and Recognition Program. This policy and process meant to assist QCCC Membership and the Board of Directors in administering the Awards program.

QCCC Awards and Recognition described below include:

- A. Lifetime Service Achievement Award (LSAA)
- B. Member of the Year (MOTY)
- C. President's Award

**A. Lifetime Service Achievement Award** - This honor may be awarded to a Club Member in recognition of outstanding prior meritorious contributions to the Queen City Corvette Club over a period of years. To be considered, the member must have been an Active Member within the last six months prior to nomination and must meet the following criteria:

1. Member must have been an Active Member of QCCC for at least ten years.
2. Provisional, Associate, Participant, Prospective or members in any other status shall not be eligible.
3. To qualify for consideration, the member must be recommended by no fewer than three (3) Active Members / Families of the Queen City Corvette Club who each have submitted to the Board the QCCC Lifetime Service Achievement Award Member Nomination Form stating why they feel this member should be considered for the LSAA Award. (See Form Below)
4. Qualifications for nomination and consideration may include but not be limited to the following:
  - a. Number of Board or Staff positions held and the number of years in those positions
  - b. Social events hosted.
  - c. Volunteering to assist with club functions.
  - d. Members nominated should promote and participate in club events, i.e., attendance at club meetings, dinners, car shows and all other official club functions.
  - e. Members nominated should exemplify and perpetuate those principles which have come to be regarded as the ideals of the Queen City Corvette Club.
5. The Board shall determine if the nomination meets the criteria for LSAA and ensure the member's overall contributions reflect the LSAA honor. The Board will then vote on final approval.
6. A special name tag / badge shall be issued to the LSAA Member as an indication of his / her achievement. Additional recognition in the form of plaques, certificates, etc., is up to the discretion of the Board. The Membership Director will be responsible to provide the recipient's name to the Webmaster for publication.

**B. The award will be selected via secret ballot vote by the membership at the November Club Meeting and announced by that President at the annual QCCC banquet during 1<sup>st</sup> quarter each year. The list of eligible Members is included in the QCCC Member Directory and the Secretary will be responsible for providing the winner's name to the webmaster for publication.

**C. President's Award** - This honor is awarded by the QCCC President each year to the Member who has gone above and beyond in club membership and has exemplified and perpetuated those principles which have come to be regarded as the ideals of the Queen City Corvette Club. The award will be selected by the President and announced by that President at the annual QCCC banquet during 1<sup>st</sup> quarter each year. The Secretary will be responsible for providing winner's names to the webmaster for publication.
