
Turn right on Sadler Road



#### OUR FIRST NCCC CONVENTION JANE & EDDIE BURT

Since becoming members of the Queen City Corvette Club in 1995, Jane and I had heard numerous club members talk about attending National NCCC Conventions and everyone seemed to have had a good time recommending that more members become involved. We never thought much about the idea until we learned that the 1999 Convention would be held in Denver, Colorado. Since we previously lived in Colorado Springs, which was one of the most enjoyable places that we ever lived, we thought "why not combine the Convention with a mini-vacation" thus killing two birds with one stone.

With this in mind, we decided "let's do it". Since Jane could take only two weeks vacation, we decided that I would drive the Corvette to Denver and pick her up at the airport.

After completing all the paper work, I had a few questions - contacting Ellouise Morrison of the Colorado West Corvette Club. Ellouise was one of the nicest, knowledgeable, and most helpful individuals I ever dealt with - answering all my concerns as well as suggesting the idea of our meeting at the hotel so she could show us around.

With everything done, the journey begins at daybreak on Monday morning, July 19 with a feeling of excitement and anticipation. For you guys with that sense of adventure, always wondering what's over the next hill, you know the feeling.

First stop - Nashville, Tennessee to visit a friend of mine whose friendship dates back to 1963. Monday night we threw some steaks on the grill, had a few cold ones, and reminisced about old times - what fun! The next day was spent touring Nashville seeing all the usual tourist sites as well as several homes of country and western stars: Minnie Pearl, Alan Jackson, Conway Twitty, etc. One of the most unpretentious was that of Waylon Jennings. It was located on a busy street with no guarded gate or security. In other words, I could have pulled into the drive, rang the bell and said, "Hello Waylon" (he'd probably have called the cops though). One of the most memorable sites was an old stone train depot converted to a Wyndham Hotel. It was fantastic.

On Wednesday morning, it was time to go, so bright and early, I said my good-byes. As I approached Nashville's city limits, I set the Corvette's suspension on "touring", rolled down the windows, turned the radio to a great oldies station while, at the time humming, "Going To Kansas City." I approach St. Louis

heading due West and it becomes hotter and hotter; 90 - 92 - 94 - 96 - 97. As I near my destination, Kansas City, I decide to cover a few more miles so the last day on the road would not be so long. Anyway, with a 75 mph speed limit, I was covering a lot of territory in a short period of time. Finally, about 6 or 7, I stopped in a small Kansas town called Junction City. Nothing there, so I grabbed a quick burger, watched a little TV, and set my sights on the next day.

Daybreak was greeted with renewed enthusiasm - bright and sunny, temperature about 70, only 450 more miles to go with a speed limit of 75. Uneventful day, as anyone who has ever driven across Kansas knows. I arrived in Aurora (a Denver suburb) midafternoon, checked in, had a bite to eat, awaiting Jane's arrival the next day.

Next morning, I got up early so I could witness the morning sun shimmer off the Rockies. It was an even more beautiful sight since several of the peaks had some snow. If you've never seen this, you don't know what you've missed.

I prepared to pick Jane up at the airport later on that afternoon. Note: be sure you have a full tank of gas when going to the airport since it's way out in the middle of nowhere. You might also want to pack a lunch.

Jane's plane arrived and I anxiously awaited her deplaneing. Many people got off the plane, but no Jane. Finally, coming up the ramp was none other than Betty and Larry Gunter, followed by Jay and Rena Freeman, as well as Pete and Gail Dawley. My first question was "Have you seen Jane?" Of course, she happened to occupy the very last seat in the plane and one of the last people to deplane. Typically, just one of the things that happens that simply drives me nuts. Such is life with Jane.

On Saturday morning, we proceeded to Registration where we were greated by members of the Colorado West Corvette Club, received our identification badges, Convention patches, as well as several other Corvette related items. We visited the Hospitality Room which was open the entire week. There were soft drinks, coffee, beer, snacks, etc. We met several club members from other clubs and in all honesty, did not meet anyone we didn't like. Later on that evening, we had a Welcoming Party in a huge ballroom where sodas, beer, and wine were furnished. There was also a DJ with all kinds of music, resulting in a dance that lasted until 12 or 1 that night. Needless to say, Jane was right in the big middle wanting to dance every dance - great night.

Sunday morning, the Corvette Mall was open where you could purchase all kinds of Corvette apparel, models, trinkets, etc. We went for the Convention shirts that were really nice. In the hotel lobby, we met even more club members; likewise, in the Hospitality Room. That afternoon, we went to the heart of downtown Denver to stroll up and down 16th Street which was approximately two miles long with no traffic allowed other than street cars. We went into every kind of a store imaginable and yes, Jane had to have a Hard Rock Cafe t-shirt. Sunday evening, we dressed in our jeans, cowboy boots, hats, etc. and attended that night's Western Welcome Party. We drank a little beer, did a little two-stepping, and had a great time. Met some folks from the Road Runners Club out of Phoenix and had a super evening. Once again, couldn't drag Jane home until

Monday, we toured the Concours staging area seeing some super nice Corvettes. However, we have some cars in our club that could have competed with the best of them. We observed many of the rallye people depart from the hotel with excitement and enthusiasm. We did a little sightseeing around Denver, returning for the Southwestern Buffet, followed by a "Legends of Rock and Roll Show and Party". We had all the great Mexican food we could eat, all the beer we could drink, and watched a group from Montana that could really entertain. One guy did Elvis impersonations and he was great; another did Brenda Lee who was also good, but in my opinion, the one that did an impersonation of Janis Joplin was simply fantastic. For you guys that attended our Saturday night BBQ, you know about the other singer, Barbie. If you didn't attend the BBQ, just ask Jay Freeman or Larry Gunter. They will fill you in. I might add at this point, that we continued to enjoy the company of the Freemans, Gunters, and Worrells, who now reside in Colorado. Once again, our night ended around 12:30.

Tuesday, we decided to take a trip down to Colorado Springs to see some people we knew from living there previously. We did our visiting and then had lunch at one of our favorite places; Gusseppies, an old train depot converted to a restaurant. What makes it so neat, is that you can sit within 15 feet of the railroad tracks where trains continue to pass. In fact, there were two that passed as we ate. They were transporting coal from Colorado to somewhere. After lunch we visited "Old Town" primarily to check out the art galleries - had a great afternoon. That night, there was another huge party called "Club Night". All the people dressed in Club apparel; hats or shirts. We also had refreshments, as well as a DJ. Once again, Jane had to "close 'em down."

Leaving Houston, we went through south Louisiana with its moss laden live oak trees and sugar cane fields, spending our final night in Gulfport, MS. We had an excellent Gulf seafood dinner overlooking the Gulf of Mexico. What a way to end our trip. Next day, we came home with memories we will never forget, friendships we will continue to keep, and I might add, much thinner wallets.

In closing, I hope that each of you that have never attended a Corvette Convention, now have a better understanding of what goes on and a better idea of what to expect when you attend your first Convention. Both Jane and I urge you to seriously consider attending a Convention in the future so that you can experience, firsthand, the enjoyment associated with meeting, dining, and competing with the thousands of Corvette owners just like yourself.
